AORN-LA CHAPTER #0507 MEETING MINUTES November 8, 2017

1. WELCOME – INTRODUCTIONS

The LA Chapter met face to face at USC Keck Medical Center in the Cardinal Room. Networking time was provided as the members gathered and selected their meal options. The meeting was opened at 17:30 by Chapter President Suzy Axt. Ms. Axt introduced herself and went around the room asking that attendees say a few things about themselves to the group.

2. PRESENTATION

A. Preventing Hypothermia

Presented by Pattie Benton, RN – Staff RN, OR Department, Keck Medical Center @ USC Pattie gave an informative presentation on the topic of hypothermia. She provided an overview that touched on who it affects, what to look for in terms of symptoms, how it manifests, and ways to prevent it.

B. Where's the MH Cart?

Presented by Debra Guy, RN — Clinical Educator, Perioperative Services, Adventist Health Glendale

Debra's presentation discussed the importance of having a plan to follow in the event an MH

crisis occurs. She discussed in methodical detail how malignant hyperthermia is triggered, & what

current practices are followed (36 vials of Dantrolene in 60cc syringe; Revonto powder

alternative). To impress upon her audience the importance of being aware of the symptoms of

MH, and the protocol to follow in order during an MH crisis, she referenced an example of an

MH case which involved a young child who was rushed to the hospital with unexplained,

uncontrolled high temperature, muscle tightness and inability to open mouth for intubation. The

ill-prepared hospital staff misdiagnosed the child's symptoms, did not render proper aid specific

for MH cases and as a result, the child passed away. Debra stressed the importance of making

sure staff are trained when a Code MH is called, and to be sure that their facility's policy on the

subject is current and follows the MHAUS standards of practice. Of significance is the fact that

MH can occur anywhere intubation occurs and that outlying areas must have equipment & meds

available within 10 minutes. TJC is auditing education & response in areas other than the OR.

3. BUSINESS MEETING

- **A.** The minutes from September 13th were approved as read.
- **B.** Treasurers report Pattie Benton, Chapter Treasurer reported the following:
 - 1. After the \$500 contribution to the AORN-Houston chapter for Hurricane Harvey disaster relief which was unanimously approved at our September 13th meeting, our chapter had an Opening Balance of \$13,168.33. A deposit of \$2,113.25 was made from membership renewal dues, bringing the Closing Balance to \$15,281.58.

- 2. The merge of the East San Gabriel chapter to AORN-LA chapter added over \$22K to our closing balance from their chapter's funds.
- 3. With the AORN-LA chapter's financial health on the upswing, it was proposed to investigate offering scholarship opportunities to our active members.
- C. Chapter Merge with East San Gabriel Valley update
 - Total membership for AORN-LA chapter increased by well over 200 members from the merge with East San Gabriel's chapter. This will be discussed at the Board meeting December 9th.
 - 2. The merge is now complete with headquarters and all members info has been merged.
